## RELEASE, INDEMNIFICATION AND HOLD HARMLESS AGREEMENT

I hereby request that I be allowed to participate in the trip and program linked to this agreement sponsored by T'ruah: The Rabbinic Call for Human Rights.

As a condition of the acceptance of my application, I agree as follows:

• I agree to abide and be bound by T'ruah's instructions for the conduct of participants in the trip or program.

• I certify that I am in good health and have no physical or mental condition that would prevent or impair my participation in this trip or program. In no event shall T'ruah be responsible for any emergency transportation, medical care or hospitalization incurred prior to, during, and/or after said trip or program.

• I have been strongly encouraged to refer to the following website for local security warnings and updates: The U.S. Embassy in Israel: https://il.usembassy.gov/.

• I have voluntarily enrolled in the trip or program. I understand that I am subject to the laws of the country I am visiting, and that T'ruah cannot be accountable for the actions of governments or their representatives.
